3. DECLARATION OF THE TRUST AND ITS OBJECTIVES.

The trustees hereby declare that they and the survivors of them or other trustee or trustees here of the time being will hold the said sum of Rs.20.000/- (Rupees Twenty thousand) made by the settlor to the trustees as aforesaid and all Gifts. contributions, subscription, donations, request and other moneys all properties as and when the -same shall be paid to or invested in them and the moneys, investments and properties as from time to time representing the same upon trust to apply the same for the benefit and welfare of the economically and socially down trodden and backward people of the society of all the communities in their social, economical, cultural and particularily for their educational development and for the advancement of any other object of their general utility and to do all or any of the followings: -

- i) To promote litracy and impart education by opening institution any where in India.
- ii) To promote distence education, computor education and disseminate knowledge in the

field of soft ware and hard ware technology.

- iii) To establish, promote, guide and encurrage institutions for education irrespective of religion, race, caste, community or social status.

4. MANAGEMENT OF TRUST

The Chairman of the Trust shall be Sri Rakesh Kumar son of Late Ramjee Prasad Sahu and the two Vice Chairman of the Trust would be Mr. Sunder Kumar S/o Dr. Mahesh Sah and Sri Santosh Kumar son of Late Ramjee Prasad Sahu.
